## Instructions For GUARDIAN AD LITEM

#### WHEN TO USE THIS PACKET

Use this packet if you are under 18 years old and have not been emancipated and are the parent of a child and you want to file paper work to establish paternity and/or get orders for custody, visitation and support for your child. You can also use this packet if you are asking for a restraining order on behalf of a minor.

#### STEPS IN PREPARING THE GUARDIAN AD LITEM:

The forms in this packet can be used if you are a minor and the parent of a child. If you are a minor, you cannot represent yourself in a court action and need to have the court appoint you a Guardian Ad Litem. You can choose one of your parents or another adult to be your Guardian Ad Litem for the purpose of getting an order for custody, visitation and support of your child. This packet is completed along with the Petition to Establish Parental Relationship or to respond to a Governmental Summons and Complaint.

- 2. Have the Fresno Superior Court Self-Help Center review your completed documents
